## Clean Soil Acceptance Agreement Form

(There are 3 ways to provide this form to us!)

1. Provide your own hardcopy of this form, filled out and signed to our yard site at address above (free)
2. Obtain a Clean Soil Acceptance Form at our yard/site, fill it out, sign it and provide it to us (a \$12 processing charge is applied)
3. Send a picture of filled out/signed copy by Text to **(425) 770-1033**. (a \$12 processing charge is applied)

Before Joe's Landscaping Supplies ("JLS") can accept any material for deposit on property owned or leased by JLS, this Agreement must be executed. JLS requires an individual, owner or officer of your firm (the Company) to execute this Agreement. By signing this Agreement, the signature certifies that all material delivered to JLS is clean soil (as defined in WAC 173-350), free of contaminants that exceed cleanup levels, and does not contain radioactive wastes, dangerous or extremely hazardous wastes (as defined by WAC 173-340), petroleum or it's by-products, soil removed as part of any clean-up action ("problem waste"), demolition waste, wood waste, any other solid waste.

JLS reserves the right to inspect, sample, and/or require the Company to sample any and all material before accepting the material. This right does not relieve the individual or Company of its responsibility to tender only clean soil as defined in the preceding paragraph. Any material that is not clean soil will be rejected. Removal and disposal of the rejected material is the sole responsibility of the Company. **If, after acceptance, the material is discovered not to be clean soil, JLS will notify the individual or Company. If requested, the individual or Company must remove the material within 24 hours of notification.**

The individual or Company agrees to defend, indemnify, and hold JLS harmless from and against any and all claims, demands, causes of action, damages, liabilities, losses, expenses, penalties, and all costs of defense relative thereto, including any breach of the Company's obligation to deliver only clean soil. **There is a Minimum \$250 Charge on Debit/Credit Card** for fees or fines or all claims, demands, causes of action, damages, liabilities, losses, expenses, penalties, and all costs of defense relative thereto, including any breach of the Company's obligation to deliver only clean soil.
